

#### **HISTORICAL EVENTS:**

In order to add some interesting facts about the history of the Regiment Jack Hallanan suggested we add this section to the Monthly Bulletin


During the month of May you will see members of the American Legion and the Veterans of Foreign Wars offering poppies for a donation to assist their Veteran Programs. This tradition relates to the poppies that grew wild in Europe during WWI. The incident and poem are related to the Canadian Army and prior to the United State being involved in that war. I thought that with the Veteran Corps

remembering our past members this is an appropriate inclusion in the Bulletin.

To commemorate our Memorial Day let us keep in mind the solemnity of the day as we pay homage to all who have ever made the Ultimate Sacrifice for freedom.

During the second battle of Ypres during WWI a Canadian artillery officer, Lieutenant Alex Helmer, was killed on 2 May 1915 by an exploding shell. He was a friend of the Canadian military doctor, Major John McCrae.

Major McDrae was asked to conduct the burial service owing to the Chaplain being called away on duty elsewhere. It is believed that later that evening McCrae began the draft for his famous poem 'In Flanders Field"



I'm not sure if it is still required but I do know that a few short years ago the High School Graduates would not receive their diplomas if they could not receipt the poem "In Flanders Field" by memory.

On Sunday, May 15th when we visit 1st Calvary cemetery we could also view the grave of BG Michael Corcoran who with his wife is buried very close to the Veteran Corps Memorial.

Our Jan/Feb Bulletin's Historical section was dedicated to this.

Obsequies of Mes. General Corcoran, wife of Brigadier General Michael Corcoran, took place from her late
residence, No. 384 Broome street. There was a large attendance of the relatives and friends of the family, and
among those present we noticed the Hon. Judge Hilton,
Col. Robert Nugent, Col. McEvily, Lieutenant Colonels
Reed and Flead, Capt. James B. Kirker, Lieutenant William J. Kane, Dr. E. D. Connery, John O'Mahoney, Esq.,
Quartermaster Tully and a number of officers of the Sixty ninth regiment, besides General Corcoran himself,
who had come on from Washington the day previous to
attend the funeral. The religious coremonies took place
attend the funeral. The religious coremonies took place
attend o'clock A. M. at St. Patrick's Catnedral, which was
most densely crowded. A solemn requiem mass was celebrated by the Very Rev. William Starrs, V. G., assisted
by the Rev. Fathers Mooney, Donnelly and McSweeny.
The coffin, containing the remains, was placed in the
centre aisle, in full view of the whole assemblage. On
the lid was a plate containing the following inscription:—

ELIZABETH CORCORAN,
AGED 35 YEARS,
DIED AUGUST 4, 1863.
Born in Ireland, county Westmeath.

At the conclusion of the religious ceremonies the remains were conveyed to Calvary Cemetery, followed by a long procession of over one hundred carriages and a large number of people on foot.
